BRIEFING NOTE

Subject: Five Year Capital Plan Submission 2021/22

Date: May 26, 2020

Purpose

The purpose of this briefing note is to provide information relevant for the committee's review and the Boards approval of the Capital Plan Submission for 2021/2022. If these projects are subsequently approved by the Ministry, funding will be announced in March of 2021.

Our new submission deadline is July 31, 2020. Included in the plan are some 'carry forward' projects that appeared in last year's submission as well as the addition of some newer projects more recently identified.

The Capital Plan Submission Summary for 2020/2021 is included as attachment #1. A summary table with further explanation is below.

Additions Projects

Last year's submission included an addition to Parkland to house the Marine Program. This project has been removed from the capital plan as the Ministry has advised funding will not be provided for a specialty industrial education space.

Through the Long Range Facilities Planning project we were able to have new projections built for all our schools. This information was used to see that we need more spaces in our south zone elementary schools specifically at Prospect Lake. Please see chart below from the LRFP that shows a projected decrease in enrollment in 2024 at Cordova Bay and Lochside as restrictions on OOC and OOD students are implemented, but an increase for Prospect Lake despite restrictions. Last year's submission for an expansion at Cordova Bay has been removed. Please note that if we run into ALC hurdles that make the Prospect Lake site expansion not possible, we will shift into a plan to modify catchment areas between Prospect Lake, Lochside and Cordova Bay and move the addition project to Cordova Bay as the most likely location.




Figure 6.2C: Chart showing 2024 Capacity Utilization

SMP Projects

The Children's Development Centre Project has been approved and is scheduled to break ground in June of this year.

Revised building codes have identified Sidney and Brentwood Elementary as H1 risk which resulted in their submissions. Note that both Sidney and Brentwood were submitted last year as a replacement based on the condition of the facility. The H1 rating will drive the rational for approval.

BEP projects

Bayside is being submitted again for a major building envelope project to repair the sustained damage from the lengthy roof leak. Note that we have conducted thorough air quality tests at the school and there are no concerns regarding air quality. Brentwood and Prospect Lake have been added after absence from the list last year. This is under instruction from the Ministry as they continue to fund related projects across the province based on studies completed in 2009 related to the leaky condo issues in BC.

SEP Projects

Roofing continues to be a focus in replacement schedules, thus the allocation of \$500K for Claremont roof section #7. This roof is being submitted in conjunction with other roofs being completed at Lochside and Keating in AFG in an effort to get schedules on track.

The boiler plant at Bayside was submitted in last year's submission and it was not approved. The boiler system is both aged and not efficient. In follow up discussions with the Ministry we were advised that we should put the project into the SEP category. This submission is a result of this conversation.

Carbon Neutral Capital Program

We have placed the heating system at the CDC new build on the CNCP projects as result of guidance from the Ministry of Education. The plan is to see if we can get separate funding that will free up monies when and if they are required in the new CDC construction project.

During the budget crunch in the planning phase of the CDC new build we were forced to remove solar panels from the project in order to stay within budget. This submission intended to add them back into the project via separate CNCP funding.

PEP projects

A new playground at Sidney Elementary was funded in 2018/ 2019. Keating Elementary received funds to construct a new playground through cost savings resulting from the Keating Seismic / Upgrade project completed in September 2020. This year we are submitting a request for funding of a replacement

playground at Brentwood Elementary that is approaching end of life and has had several pieces removed due to damage and age.

In addition we are submitting for a new playground at the CDC as the existing playground is very small and aged. The nature of the school does not lend well to any PAC funding for a playground.

Recommendation:

That the Board approve the list of projects to be included on the Capital Plan Submission (listed above) for the 2021/22 school year.

Additions Projects

Last year's submission included an addition to Parkland School to house the Marine Program. This submission was not approved by the Ministry so this is a follow up request.

SMP Projects

Last year's submission included the Child Development Centre. We are currently awaiting final Ministry approval.

Revised building codes have identified Sydney and Brentwood Elementary as H1 risk which resulted in their submissions. Note that Sydney Elementary was submitted last year as a replacement based on the condition of the facility. The H1 rating will drive the rational for approval.

BEP projects

Bayside is being submitted again for a major building envelope project to repair the sustained damage from the lengthy roof leak. Note that we have conducted thorough air quality tests at the school and there are no concerns regarding air quality. Brentwood and Prospect Lake have been added after absence from the list last year. This is under instruction from the Ministry as they continue to fund related projects across the province based on studies completed in 2009 related to the leaky condo issues in British Columbia.

SEP Projects

Dust collectors at Stellys, North Saanich and Parkland Schools are remaining on the list as outstanding health and safety projects.

Roofing continues to be a focus in replacement schedules, thus the requests for Lochside, Keating and the School Board office. All these roofs are beyond life expectancy and require replacement. These roofs are being submitted in conjunction with other roofs being completed in AFG in an effort to get schedules on track.

The Boiler Plant at Bayside is an older system that is not efficient compared to today's standard and the boilers are reaching end of expected life. They are the highest priority boiler replacements in the district.

PEP projects

A new playground at Sydney Elementary was funded in our last submission. Keating is the next priority as we will be reclaiming land from portable removals and will be utilizing the space as play area in the future. Keating lost play area with the seismic upgrade and expansion currently underway with completion coming in September 2019.

Recommendation:

That the Board of Education for School District No. 63 (Saanich), Approve the list of projects to be included on the Capital Plan Submission (listed above) for the 2020 / 2021 school year.
